## **ISCOS celebrates 35 years of supporting ex-offenders in Singapore**

Singapore, 9 November 2024 –The Industrial and Services Co-operative Society Limited ('ISCOS'), Singapore's only co-operative for ex-offenders, proudly celebrated its 35<sup>th</sup> anniversary today at a joint appreciation lunch with NeuGen Fund ('NeuGen'). The event, attended by 250 sponsors, donors, volunteers, Titans, and other stakeholders, underscored ISCOS' enduring commitment to helping over 20,000 members rebuild their lives and reintegrate into society. Reflecting its tagline 'You've Got A Friend', countless individuals had been supported through key initiatives such as the Skills Assistance Subsidy Scheme, pro-social support groups and its signature Titans<sup>1</sup> programme.

Held at PARKROYAL COLLECTION Marina Bay, the celebration was graced by Madam Halimah Yacob, Chancellor of Singapore University of Social Sciences and former President of The Republic of Singapore as the Guest of Honour. In addition to the tokens of appreciation given to donors, volunteers and Titans, the programme featured a screening of ISCOS' commemorative video along with cake-cutting ceremony to mark the joyous occasion.

In her speech, Madam Halimah Yacob highlighted the inspiring journey of Mohammed Fairizal Jaffar, a Titan who overcame multiple incarcerations. After diligently studying while in prison, Fairizal secured employment with Infinite Transport upon his release in 2015, and has since risen to the position of Operations Manager. Despite the tight work schedule, he remains actively involved in the Desistance Project and school talks. "Fairizal's journey is just one of many, showcasing the amazing passion of the Titans to inspire the lives around them," concluded Madam Halimah Yacob in recognising their immense value and contributions.

Among the volunteers appreciated at the event, Koh See Khiang was celebrated with the 'World Changer Award' for his exceptional dedication as a Family Befriender, supporting three families within the NeuGen network. His genuine care and commitment to fostering growth made him a truly deserving recipient.

<sup>1</sup> The Titans programme by ISCOS involves a selected pool of ex-offenders who have successfully reintegrated into society and are given opportunities to give back to society through community outreach and engagement with inmates, at-risk youths and members of public.

<sup>2</sup> Institutions of a Public Character (IPCs) are exempt or registered charities which are able to issue tax deductible receipts for qualifying donations to donors. In other words, donors can claim tax relief from their assessable income based on the amount donated, at prevailing deduction rate. As this makes IPCs more appealing to donors in attracting donations, these organisations are rightfully held to a higher standard, both in terms of regulatory compliance as well as governance.
